Bill Status: Failed to pass; session ended.

## Actival Colorado - HB 1128

<u>Bill Status:</u> HB 1128 was passed by the House (63-2). Introduced to Senate and assigned to Senate Health and Human Services Cmte. Senate Cmte referred amended to appropriations on 4/28. <a href="Sponsor(s): Rep. Bob McCluskey-R">Sponsor(s): Rep. Bob McCluskey-R</a>; Sen. Bob Hagedorn-D <a href="Other Information: National Conference of Insurance Legislators">Other Information: National Conference of Insurance Legislators</a> (NCOIL) model, which was based on CU model act.

#### Connecticut

Bill Status: Failed to Pass

<u>Last Action:</u> Multiple hospital infection reporting bills were proposed to Joint Committee on Public Health but all were dropped because the Committee believes that an existing public health law (Public Act 02-125) does what these bills do. The law currently requires the DPH to record "adverse events," including hospital acquired infections that result in the death or serious injury of a patient. However, there is no public information on the CT Dept of Public Health (DPH) website of adverse events or hospital infections.

Other Information: The bill could be picked up again next January.

#### Kentucky – HB76; SB185

Bill Status: Failed to pass; session ended

<u>Last Action:</u> HB76 passed by House on 2-23-05 (vote: 81-13) and referred to Senate Health and Welfare Committee; SB 185 referred to Health and Welfare Committee, no action.

## Maryland – HB199

HF 87 filed is based the CU model act; SB986: expands the Adverse Health Care Events Reporting Act to include facility-acquired infection rates; prohibiting the nontherapeutic use of animal feed containing certain antibiotics; establishing a surcharge on all commercial feeds sold that contain antibiotics; appropriating money.

<u>Status:</u> Passed by house unanimously on 4/25. Sent to Senate. Referred to Cmte on Human Resources and Education. <u>Sponsor(s):</u> OHRENSCHALL, PIERCE, LESLIE, ALLEN, ATKINSON, CLABORN, GERHARDT, HOGAN, HORNE, MANENDO, MORTENSON, MUNFORD, OCEGUERA AND SMITH; JOINT SPONSORS: SENATORS AMODEI, CARE

Other Information: Requires certain medical facilities to report hospital-acquired infections as sentinel events to the Health Division of the Department of Human Resources. **Does not make data publicly available.** Reports to the Repository for Health Care Quality Assurance.

## New Jersey - S1390, A2644, A3461

<u>Bill Status:</u> SB 1390 referred to Senate Health, Human Services and Senior Citizens Committee (3-29-04); A2644 referred to Assembly Health and Human Services Committee (5-3-04); A3461 Referred to Assembly Health and Human Services Committee (11-04-04). <u>Sponsor(s):</u> SB1390 - Senators Leonard Connors-R and Henry McNamara-R; co-sp, Andrew Ciesla; A2644 - Assemblymen Christopher Connors-R and Brian Rumpf-R; A3461 – Assemblymen Joseph Vas.

New Mexico - HB934, SJM45, HJM62, SB775, HB823

<u>Bill Status:</u> All proposals failed to pass; session ended.

<u>Last Action</u>: **HB934** passed by the House; referred to the Senate Committee. The bill would have required public reporting of hospital-acquired infection rates.

<u>Sponsor(s):</u> HB 934 - Rep. Rodella; SJM 45--Sen. Michael Sanchez; HJM 62--Rep. Vaughn.

Other Information: SJM 45 (requiring a study on hospital-acquired infection rates) passed by the Senate and placed on the Senate Calendar. HJM 62 (requiring a study to determine if reporting hospital infection rates is in the public's interest).passed by the House and referred to Senate Rules Committee. Two other public reporting bills were filed but had no action: SB 775 – Sen. Jennings and HB 823 - Rep. Anderson.

New York - A3543 (S53), A5813, S2953, A463, A5001, A5451

<u>Bill Status:</u> A3543 (companion S53) passed the Assembly, sent to Senate and then returned to Assembly and amended. It repassed the

Assembly and returned to Senate Health Committee. All other Assembly bills referred to Assembly Health Committee S. 2953 referred to Senate Committee on Health.

<u>Sponsor(s)</u>: A3543 – Assembly member Gottfried, S53 – Senator DeFrancisco; A5813 – Assembly member Bradley; S2953 – Senator Spano; A463 –Assembly members Markey and Eddington; A5001-Assembly member Calhoun; A5451- Assembly member McDonough. <u>Other Information</u>: Assembly member Grannis is working in the Health Budget Conference Committee to secure funding for hospital infection reporting.

<u>Last Action:</u> HB2366 referred to House Health and Human Services Committee w/ subsequent referral to Ways and Means (1-21-05); SB400 referred to Health Policy, then Ways and Means, public hearing held on 2-7-05.

<u>Bill Status:</u> Bills referred to Senate Health and Human Services Committee 1-6-05 and 2-17-05. S20 postponed; no action anticipated. S804 recommended for further study; could come up again. <u>Sponsor(s):</u> SB20 - Sen. John McBurney; SB804 – Sen. Galo, Walaska, Fogarty P, Felag, Levesque.

Other Information: SB 609 (Sen. Jane Nelson), a study bill that delays action for two years passed by the Senate. A Consumers Union-backed Senate floor amendment to strengthen SB 609 was not approved. SB 609 now will be considered by the House Public Health Committee. There will be further opportunities to strengthen the bill in the House.

## West Virginia – HB2180

<u>Bill Status:</u> Failed to pass; session ended.

referral to Judiciary.

## States with laws requiring hospital-acquired infection reporting as of 1-05

#### Florida

<u>Status:</u> Law passed in 2004. Implementation by the Agency for Health Care Administration; committee of stakeholders organized to develop implementation plan.

<u>History:</u> The law requiring hospital infection reporting is a brief statement requiring reporting infection rates to the public. Backed by the "Health Check" coalition. Originally contained in companion bills HB 701 (Rep. Donna Clarke) and SB 2022 (Senator J.B. Alexander); the provision on hospital infection reporting was passed as a part of a larger health bill, HB1629/SB2910.

#### Illinois

<u>Status:</u> Law passed in 2003. Currently in the process of being implemented. This bill also required reporting on nurse staffing ratios.

#### Missouri

<u>Status:</u> Law passed in 2004 and is currently being implemented by the Department of Health and Senior Services

## Pennsylvania

<u>Status:</u> Under a general law on hospital quality, the Pennsylvania Health Care Cost Containment Council (PHC4) was given the authority to collect and report hospital-acquired infection rates. PHC4 is currently collecting data from PA hospitals but has not yet issued a public report on rates.
